All Applicants are to submit the following (*check-list for all applications*)

- 1) Rock Hill Liquor License application completed in full with all necessary attachments.
- 2) Check for the appropriate fee.
 - a. Fees are to be paid in full at the time of application.
- 3) A letter from the property owner granting permission for the sale of alcohol on the premises.

Liquor Licenses must be reviewed & approved by the Board of Alderman prior to issuance. Contact the City Clerk at 314-561-4315 for the deadline to be placed on the agenda.
