Dumpster/Trash Container Requirements

No Dumpster or Trash Container will be allowed prior to issuance of permit by the City of Rock Hill.

Dumpsters and trash storage containers shall not be allowed on any residential property unless a permit has been issued by the City of Rock Hill. The maximum allowed time is 2 months. An extension of two additional periods of 2 months each will be allowed upon payment of fees for each extension of the permit. A maximum of 6 months in any given 12 month period will be allowed for the use of a dumpster/container, per lot.

Adjoining property must be protected at all times from trash and debris. A cover is required on the dumpster/container when not in use.

The dumpster/container will be screened from public view to the greatest extent possible and shall not be a distraction or impediment to traffic or create a hazard to the public sidewalks and rights of way. The dumpster must be at least 6' behind the curb line and should not be placed on the sidewalk nor on the street or road.

Certain special wastes that are hazardous or toxic shall not be allowed in the dumpster/container. Provisions shall be made for the proper storage of these wastes.

Dumpster/container shall be emptied a minimum of every two weeks or when full whichever occurs first.

Dumpster/container shall be stored on a hard surface (concrete, asphalt). The area surrounding the dumpster/container shall be kept clean, neat, and in sanitary conditions.

Dumpster/container shall be leak-proof, waterproof, and properly covered when not in use. Blowing trash and debris will be the responsibility of the applicant to remove from neighboring property and streets

Dumpster/Container shall be removed immediately upon expiration of the permit, unless extended with proper permit extensions and fees.

Violation of any part of these conditions can result in a court notice and fine as provided in the General Municipal Codes.
