a) Bill No. 1992: AN ORDINANCE OF THE CITY OF ROCK HILL, MISSOURI AMENDING CHAPTER 405 ARTICLE VIII OF THE MUNICIPAL CODE BY ADDING A NEW SUB-CLASSIFICATION, PLANNED DEVELOPMENT-INDUSTRIAL, IN THE PLANNED DEVELOPMENT ZONING DISTRICT.
