City of Rock Hill Minutes for the Board of Aldermen meeting, Tuesday, November 2, 2021 7:00 p.m.

- **1.** Mayor Mahan called the meeting to order at 7:00 p.m. and led everyone in the Pledge of Allegiance.
- 2. The Mayor called the roll and the following members of the Aldermanic Board were in attendance: Alderman Took, Alderman Johnson, Alderman Wofford, and Alderman Westfall. Alderman Rappold and Alderman Davis were absent.
