Minutes for the Board of Aldermen meeting,  
Tuesday, November 16, 2021  
7:00 p.m.**

1. Mayor Mahan called the meeting to order at 7:00 p.m. and led everyone in the Pledge of Allegiance.
2. The Mayor called the roll and the following members of the Aldermanic Board were in attendance: Alderman Took, Alderman Davis Alderman Johnson, and Alderman Wofford. Alderman Rappold was absent. Alderman Westfall later joined the Dais.
