Minutes for the Board of Aldermen meeting,
Tuesday, April 4, 2023
7:00 p.m.**

1. Mayor Mahan called the meeting to order at 7:00 p.m. and led everyone in the Pledge of Allegiance.
2. The Mayor called the roll and the following members of the Aldermanic Board were in attendance: Alderman Took, Alderman Westfall, Alderman Wiley and Alderman Weider via phone.
3. **Bills and Resolutions:** Pursuant to RSMo. 79.130, all bills and resolutions will be read by “title” only. Copies will be available to the General Public at City Hall during regular office hours.

ITEMS TO BE CONSIDERED FOR FIRST READING:

- a) **Bill No. 2027:** AN ORDINANCE OF THE CITY OF ROCK HILL, MISSOURI AUTHORIZING THE CITY ADMINISTRATOR TO EXECUTE A COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY OF ROCK HILL, MO AND THE ROCK HILL FIRE DEPARTMENT SHOP, LOCAL 2665, INTERNATIONAL ASSOCIATION OF FIREFIGHTERS
