Minutes for the Board of Aldermen meeting,
Tuesday, August 1, 2023
7:00 p.m.**

1. Mayor Mahan called the meeting to order at 7:00 p.m. and led everyone in the Pledge of Allegiance.
2. The Mayor called the roll and the following members of the Aldermanic Board were in attendance: Alderman Took, Alderman Davis, Alderman Johnson, Alderman Weider, Alderman Westfall, and Alderman Wiley.

 - a. Mayor Mahan presented a Proclamation for Jennifer Yackley
5. **Minutes of Previous Meeting** – July 18, 2023: Alderman Weider moved and Alderman Took seconded a motion to approve the minutes for the July 18 2023 meeting. The minutes were approved unanimously by voice vote.
