Minutes for the Board of Aldermen meeting  
Tuesday, October 17, 2023  
7:00 p.m.**

- 1) Mayor Mahan called the meeting to order at 7:00 p.m. and led everyone in the Pledge of Allegiance.
- 2) The Mayor called the roll and the following members of the Aldermanice Board were in attendance: Alderman Jeff Took, Alderman Jennifer Davis, Alderman Ed Johnson, Alderman Robert Weider, and Alderman Tina Wiley. Alderman Sabrina Westfall was not present.
- 3) **Citizens to Address the Board:** none.
- 4) **Announcements, Presentations, Proclamations, Communications & Invitations:** none
- 5) **Minutes of the Previous Meeting** – October 3, 2023: Alderman Johnson moved and Alderman Wiley seconded a motion to approve the minutes for the October 3, 2023 meeting. The minutes were approved unanimously by voice vote.
- 6) **Parks and Recreation Commission Report:** City Administrator Garrett Schlett reported:

- 7) **Community Development Commission Report:** City Administrator Garrett Schlett reported:  
  
The Community Development Commission thanks everyone for their support at Fall Festival. They will meet this month to evaluate this year's festival and get reading to start planning next year's festival.

- 9) **Parks and Recreation Department – City Administrator Garrett Schlett reported:**
- Parks and Rec Director Katy Neiman continues working with SWT and the construction company on Turner Park.
- 10) **Public Works Department – City Administrator Garrett Schlett reported:**
- Crews continue mowing, cleaning up parks, and hot patching on Hudson and Litzsinger.
- 11) **New and Old Business – Mayor and Board of Aldermen:** The Board discussed parking on Tavalon. Alderman Took moved and Alderman Davis seconded a motion to conditionally approve the liquor license for X-Golf – Full liquor/Sunday, pending receipt of background checks and a letter of “No Tax Due.” The motion was approved unanimously by voice vote.
- 12) **City Attorney’s Report:** City Attorney Paul Martin requested a closed session to discuss communication received from New Growth Horizon.
- 13) **City Administrator’s Report:**
- Presented new ward maps to the Board.
  - Advised that the bids for the compensation study are due on October 18, 2023.
  - The City has hired a new court administrator, Felicia Holbrook. Her start date is November 2, 2023.
  - Discussed proposed budget changes to the Police Department’s salary schedule.

The Board of Aldermen discussed the proposed changes to the Police Department’s salary schedule. Alderman Weider moved and Alderman seconded a motion to accept the proposed changes, effective October 18, 2023. The motion was approved unanimously by voice vote.
