City of Rock Hill Minutes for the Board of Aldermen meeting Tuesday, April 2, 2024 7:00 p.m.

- 1) Mayor Mahan called the meeting to order at 7:00 p.m. and led everyone in the Pledge of Allegiance.
- 2) The Mayor called the roll and the following members of the Aldermanice Board were in attendance: Alderman Tina Wiley, Alderman Sabrina Westfall, Alderman Robert Weider, and Alderman Jennifer Davis. Alderman Ed Johnson and Alderman Jeff Took were absent.
- 3) Citizens to Address the Board: none.
- 4) Announcements, Presentations, Proclamations, Communications & Invitations: Police Chief Don Wickenhauser present a letter of commendation to Lt. Mike Hassler and P.O. Tim Walker for their actions on 3/26/24 apprehending a suspect and locating a missing person.
