Minutes for the Board of Aldermen meeting,
Tuesday, August 20, 2019
7:00 p.m.**

1. Mayor Mahan called the meeting to order at 7:00 p.m. and invited Owen Halloran and Zachary Mason to lead everyone in the Pledge of Allegiance.
2. The Mayor called the roll and the following members of the Aldermanic Board were in attendance: Mr. Ed Johnson, Mr. James Killion, Ms. Mary Wofford, and Ms. Sabrina Westfall. Ms. Jackie Rappold and Mr. Robert Weider were both absent
3. **Citizens to Address the Board:**

4. **Announcements, Presentations, Proclamations, Communications & Invitations:**
 - a. Mayor presented proclamation to Zachary Mason
 - b. Owen Halloran presented an eagle scout project that he completed to the Board of Aldermen and asked permission to put up a sign for designation of the retired flag drop off.

5. **Public Hearing:**
 - a) **2019 Property Tax rates**

Mayor Mahan opened the public hearing at 7:31 p.m.

City Treasurer Sandy Stephens explained the details of the proposed 2019 Property Tax rates.

Mrs. Stephens asked if there were any questions from the Board.

City Administrator Jennifer Yackley entered into the record the public hearing notice, the affidavit of publication, and the staff memo including the proposed rates for the 2018 taxes.

7. **Minutes of Previous Meeting** – August 20, 2019: Alderman westfall moved and Alderman Johnson seconded a motion to approve the minutes for the June 4, 2019 meeting. Alderman Johnson requested a couple amendments to the minutes. The minutes were approved as amended unanimously by voice vote.
8. **Parks and Recreation commission:** Al Hayden reported that the commission met the 15th of August. Matt Rearden was reelected as chairperson of Commission. Planting at Whitfield Saturday October 12.
9. **Bills and Resolutions:** Pursuant to RSMo. 79.130, all bills and resolutions will be read by “title” only. Copies will be available to the General Public at City Hall during regular office hours.

ITEMS TO BE CONSIDERED FOR FIRST READING:

- a) **Bill No. 1967: AN ORDINANCE AUTHORIZING AND DIRECTING THE CITY TO ENTER INTO AN AGREEMENT WITH THE MISSOURI OFFICE OF STATE COURTS ADMINISTRATOR AND ASSESSING A COURT AUTOMATION FEE**

City Attorney Paul Martin read **Bill No. 1967** for the first time by “title” only.

City Attorney Paul Martin read **Bill No. 1967** for the second time by “title” only.

Alderman Westfall moved and Alderman Killion seconded a motion to approve **Bill No. 1967**. Those members of the Board voting in favor of Bill No. 1967 were Alderman Westfall, Alderman Johnson, Alderman Killion. Those members voting against the motion are Alderman Wofford.

The motion passed failed for not enough affirmative votes.

City Attorney Paul Martin asked Alderman Wofford to reconsider due to the need to have this ordinance approved.

Alderman Wofford moved and Alderman Johnson seconded a motion to reconsider **Bill No. 1967**. Alderman Wofford expressed her concerns with the Missouri Supreme Court dictating a fee that the City must charge for all court fines.

Those members of the Board of Aldermen voting in favor of Bill No. 1967 were Alderman Wofford (under duress), Alderman Westfall, Alderman Johnson, and Alderman Killion. **Bill No. 1967** passed.

ITEMS TO BE CONSIDERED FOR SECOND READING:

10. Departmental Reports:

- a) **Parks and Recreation Department:** Parks and Recreation Director Al Hayden reported that the citywide garage/yard sale will be held on September 21st. The City has received the contract for the Community Development Block Grant and he has been working on final details for the Fall Festival.

- b) **Public Works Department:** Parks and Recreation Director Al Hayden reported expect to finish construction on Hardith Hills and crews have been doing mowing around the city and repairing potholes.

11. New and Old Business – Mayor and Board of Alderman:

- a) City Administrator reported that research has been completed on citywide speed limit change and asked the Board of Aldermen for direction whether to bring changes to the ordinance for speed limits. The Board of Aldermen directed to make changes and bring a Bill for consideration.

12. City Attorney's Report: No report


13. City Administrator's Report: City Administrator Jennifer Yackley nothing to report
