MINUTES FOR THE BOARD OF
ALDERMEN MEETING
TUESDAY, MAY 15, 2018
7:00 P.M.**

- 1) Mayor Mahan called the meeting to order at 7:00 p.m. and led everyone in the Pledge of Allegiance.
- 2) The Mayor called the roll and the following members of the Aldermanic Board were in attendance: Mr. Robert Weider, Mr. Philip Scherry, Mr. James Killion, Mr. Ed Johnson, and Ms. Mary Wofford. Ms. Sabrina Westfall was absent.
- 3) **Citizens to Address the Board:** none
- 4) **Announcements, Presentations, Proclamations, Communications & Invitations:**
- 5) **Minutes of Previous Meeting** – May 1, 2018. Alderman Weider moved and Alderman Wofford seconded a motion to approve the minutes for the May 1, 2018 meeting. The minutes were approved unanimously by voice vote.
- 6) **Parks and Recreation Commission Report:** Parks and Recreation Director Al Hayden reported:

City Attorney Paul Martin read Resolution 18-11 by “title” only.

Alderman Scherry moved and Alderman Weider seconded a motion to approve Resolution 18-11.

City Administrator Jennifer Yackley explained Resolution 18-11.

The motion to approve Resolution 18-11 was approved unanimously by voice vote.

- c) **Bill No. 1952:** AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR THE CITY OF ROCK HILL FOR THE PERIOD OF APRIL 1, 2017 THROUGH MARCH 31, 2018.

City Attorney Paul Martin read **Bill No. 1952** a second time by “title” only.

Alderman Scherry moved and Alderman Weider seconded a motion to approve Bill No. 1952.

Members of the Aldermanic Board voting in favor of the motion were: Weider, Scherry, Killion, Johnson, and Wofford. Motion passes with a vote of 6-0.

Bill No. 1952 becomes **Ord. No. 1969**.
