a) Bill No. 1968: AN ORDINANCE CHANGING THE ROCK HILL MUNICIPAL CODE RELATING TO SPEED LIMITS WITHIN THE CITY BY AMENDING SECTION 320.040 "GENERAL SPEED LIMIT" AND REPEALING AND REPLACING SCHEDULE II "SPEED LIMITS".
