6. Architectural review for a residential addition at 2516 Pocahontas Place.

City Administrator/City Planner Jennifer Yackley explained that a request was submitted by Sheila Miranda of Core 10 Architecture on behalf of Dave and Abbey Karsten for a 498.7 square foot addition to the rear of the existing house at 2516 Pocahontas Place. The addition will replace an existing two-story shed and deck at the rear of the house. The addition will provide a garage at the basement level, a family room on the first level and a master bedroom on the second level. The city's masonry and design element regulations are not applicable to the proposed addition. The addition will have light grey siding and trim to match the existing house. The new windows will be light grey to match the existing windows. The roof shingles will be brown to match the existing roof.

A motion was made by Wyndel Hill and seconded by Larry Schneider to approve the Architectural review for a residential addition at 2516 Pocahontas Place. The motion passed unanimously.

7. Site plan review for a residential addition at 2516 Pocahontas Place.

City Administrator/City Planner Jennifer Yackley explained that a request was submitted by Sheila Miranda of Core 10 Architecture on behalf of Dave and Abbey Karsten for a 498.7 square foot addition to the rear of the existing house at 2516 Pocahontas Place. The property is zoned "A" Residence District. The proposed addition is 498.7 square feet and 29 feet in height. The addition will create a dormer on the front façade of the house. It will also raise
