City Administrator/City Planner Jennifer Yackley explained that a request was submitted by Brian Ivy of Idea Architects, LLC on behalf of Jana Franklin of Strange Allegro for a new restaurant,

Jimmy John's, at 9721 Manchester Road. The petitioner plans on reutilizing the existing single-story property of 1,591 square feet and a small addition of 49 square feet for a total of 1,640 square feet and a total of 16 feet in height. The building exterior will be modified with added parapets, a relocated entrance, and adding a drive-through window. The city's masonry requirement is not applicable to the proposed business. The existing property is zoned "C" commercial and is in compliance with all city codes and ordinances. Signage will be reviewed under a separate permit.

Brian Ivy of Idea Architects, LLC addressed the commission to share and review renderings of the proposed facility alterations of the exterior and to take any questions. The only question raised was to confirm if new curbing will be provided around the building, which was confirmed.

10. Site Plan Review for a new Jimmy John's at 9721 Manchester Road

City Administrator/City Planner Jennifer Yackley explained that a request was submitted by Brian Ivy of Idea Architects, LLC on behalf of Jana Franklin of Strange Allegro for a new restaurant, Jimmy John's, at 9721 Manchester Road. The petitioner plans on reutilizing the existing single-story property of 1,591 square feet and a small addition of 49 square feet for a total of 1,640 square feet and a total of 16 feet in height. The city's masonry requirement is not applicable to the proposed business. The existing property is zoned "C" commercial. Signage will be reviewed under a separate permit. A light trespass study was reviewed for the new exterior lighting for the site. The study indicates if the lighting is installed properly the site will be in compliance. An exit only sign to be added at the site exit onto Leonard Ave to keep vehicles from entering off of Leonard Ave.

Brian Ivy of Idea Architects, LLC addressed the commission to share and review the site plans of the proposed facility and to take any questions. Commission member Jeff Schimek asked if there were any concerns with the proposed site plan to allow for enough space in the drive through to keep from backing up on Manchester Road. Jana Franklin indicated they see approximately 6 cars in que at her other locations. The current plans allow for 8 vehicles in line to queue and is not anticipated to be an issue.

The request is compliant with all applicable City of Rock Hill Ordinances and Staff recommends the Commission to approve the site plan and elevations for the proposed Jimmy John's.
