Pursuant to the Revised Missouri Statute 479.050, rule 37.49 of the Supreme Court Rules of the State of Missouri, and Local Court Rule 69.6, designated offenses shall be payable to the City of Rock Hill Violations Bureau.

The Violations Bureau is established a convenience to the public. It is not intended to replace a court appearance for pleas of "Not Guilty." If you believe you are not guilty of the offense charged, you should appear in court on the court date indicated on your summons.

In accordance with Missouri statutes and ordinances adopted by the City, total court costs shall be \$29.50. This includes Basic Court Costs of \$12.00, Crime Victims Compensation surcharge of \$7.50, Law Enforcement Training Fund surcharge of \$1.00, Peace Officers Standard Training Fund surcharge of \$2.00, and a Court Automation surcharge of \$7.00, for a total of \$29.50. Court costs shall be paid in addition to the fine, with the exception of seatbelt and helmet violations. Court costs are not additional fees for coming to court.

The following fines and costs have been established for the City of Rock Hill for offenses issued on or after May 1, 2020 and until further notice. However, court fines are subject to change (with an appearance in court) at the Judge's discretion. **Violations not appearing on this list are NOT payable out of court and require a court appearance.**
