Please read the instructions for liquor licenses carefully, as some things have changed, and please use the attached checklist to confirm that you have all necessary documents. We cannot issue a liquor license until the proper background check and all other supporting documents are complete.

New applicants or renewals that have a change in owner or management must have a full fingerprint background check completed by the Missouri State Highway Patrol (MSHP).

This process takes longer than a name-based check. For faster results, it is suggested that you visit a MSHP fingerprint site.

Renewals that do not have any changes in owner or management only need a name-based background check, which can be completed online at <a href="https://www.machs.mshp.dps.mo.gov">https://www.machs.mshp.dps.mo.gov</a>.

In order to be approved for renewal before your license expires, we must receive your completed application and fees by June 1, 2024.

### **Application Instructions for Liquor License(s)**

### All applicants are required to submit the following:

$\bigcirc$	1) Rock Hill Liquor License application, completed in full and notarized.
$\bigcirc$	2) A copy of your valid State liquor license.
0	3) Payment of the appropriate fees. Payment is due in full. Pro-rated fees will apply if application is made mid-year. The applicant shall pay the pro-rated amount for the remaining months of the year.
$\bigcirc$	4) A Certificate of Insurance for \$1,000 (applies to "original package" applicants only).
0	5) One (1) photograph of the exterior of the premises to be occupied (new applicants only).
0	6) Completed Applicant Release form and background check for each listed person. Note: Any application by a partnership, joint venture or group other than a corporation, shall submit a list of <b>all individuals</b> who are members of said partnership, join venture or group and a Supplemental Applicant Release form for each. <b>The initial background check must be a sealed, authenticated background check prepared by the Missouri State Highway Patrol (MSHP).</b>
$\bigcirc$	7) If the business is a corporation, supply the names and addressed of its: (1) Registered Agent; (2) Officers of the Corporation; and (3) Directors of the Corporation. If the business is a corporation, a background check is needed for the applicant and manager.
$\bigcirc$	8) Proof of voter registration in the State of Missouri (managing officer only).
0	9) A "No Sales Tax Due" letter issued from the Missouri Department of Revenue dated within the last 90 days. Copies of the letter can be printed from https://dors.mo.gov/tax/notaxdue/.
0	10) Proof of paid taxes (personal property tax receipt) of the applicant for the City, County, and State in which the applicant resides, as well as proof of paid personal property taxes associated with the businesses Rock Hill location.

### **Due Date:**

Liquor licenses must be reviewed and approved by the Board of Aldermen prior to issuance. Contact the City Clerk at 314-968-1410 for the deadline to be placed on the agenda.

#### **Change of Status:**

The applicant is required to notify the city of any changes of management or ownership or other pertinent information as soon as possible. A change in ownership requires a new application with a related review and approval. Liquor licenses are nontransferable.

#### **Expiration Date:**

Liquor licenses expire annually on June 30<sup>th</sup>.
